

Research on Support for Allowing Undocumented Immigrants to Access Medicaid in Connecticut

Findings From a Survey of 500 Likely Voters in Connecticut with Oversamples of 100 Black Voters & 100 Latinx Voters

Methodology

- Lake Research Partners designed and administered this survey, which was conducted by live telephone interview and text-to-online.
- The survey reached a total of 500 likely voters in Connecticut plus oversamples of 100 Black voters and 100 Latinx voters.
- The survey was conducted February 8-13, 2022.
- Interviews were conducted in English & Spanish.
- Data were weighted slightly by gender, region, party identification, race, age, education level to reflect the expected demographic composition of likely voters in Connecticut.
- The margin of error for the full sample is +/-4.0%.





PARTY IDENTIFICATION










Strategic Summary

- A solid majority of voters support expanding access to health coverage in Connecticut through the HUSKY program, regardless of immigration status (57%).
 - That majority holds steady throughout the survey as voters hear messages for and against the proposal. There is little movement overall, but independent women are a target group for persuasion.
 - Democrats are strongly in favor, while Independents lean against and Republicans are strongly opposed.
 - Support is overwhelming among Black and Latinx voters.
- Two-thirds of voters support the proposal to expand access to all children (66%).
 - This even more popular, less polarizing proposal gains a few points of support throughout the survey, mostly from persuadable older Republican women, and some independents.
 - Democrats are again strongly in favor, independents are in favor, and Republicans are softly opposed.
 - Black and Latinx voters are even more supportive.
- Voters' number one health care priority, across party lines, is lowering health care costs including prescription drug prices (52% rate very high priority), followed by ensuring all children in Connecticut are covered (45% rate very high priority).
 - Among Black and Latinx voters, ensuring all children are covered is a slightly higher priority.





Two thirds of voters are favorable towards the concept of "affordable healthcare for all," with high intensity. The language of "a public health care option for all" performs similarly to "Medicare for All", while "universal health care" is significantly weaker. HUSKY has higher positive intensity and fewer negative connotations than Medicaid, but is unknown to some voters, while Medicaid is recognized by all.



All Items Split Sampled


Q2. Now I'd like to ask you about some organizations and ideas. For each, please tell me whether you have a very favorable, somewhat favorable, somewhat unfavorable, or very unfavorable impression. If you haven't heard of it {6}, or if you don't know enough about it to have an impression (5), just say so and we will move on.







Voters' number one concern is taxes (33% top issue), driven by Republicans (48%). It is followed by jobs and the economy (29%) which is the number one issue of independents (37%). Democrats' top issue is health care (31%), which lands third overall (24%).




Taxes is a top issue across the board, except among Democrats, who are most concerned about health care (31%) and the economy (27%). For independents health care is a second-tier issue (20%), after the economy (37%), taxes (30%), and crime (30%). There is a gender gap – women (27%) are more concerned about health care than men (19%). Latinx voters (29%) are more concerned than Black voters (20%).


The number one health care priority, across party lines, is lowering health care costs including prescription drug prices (52% rate very high priority), followed by ensuring all children in Connecticut are covered (45%).





A clear majority of voters support allowing all Connecticut residents who qualify by income to receive insurance through HUSKY regardless of immigration status (57% support), including 84% of Democrats and nearly three quarters of people of color (72%). Black (83%) and Latinx (76%) voters in particularly are overwhelmingly supportive. Women and younger voters are also more favorable (both 61%). Independents are split but lean against the proposal (49% oppose).









Q7. Now let me tell you a little bit about the Medicaid program, also known as HUSKY, in Connecticut. As you may know, HUSKY provides health insurance to low-income and disabled Connecticut residents. Most undocumented immigrants are excluded from the program. Do you support or oppose allowing all Connecticut residents, who qualify by income, to receive insurance through HUSKY, regardless of immigration status?



There is even more robust support for allowing all <u>children</u> to receive insurance through HUSKY – two thirds of voters (66%), including 92% of Democrats, a majority of independents (58%), eight in ten people of color (80%) – including 89% of Black voters and 82% of Latinx voters – seven in ten women (70%), and nearly three quarters of younger voters (72%) are in favor.
